

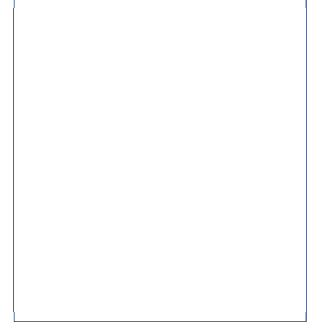

Cancellation Terms

Ravel Roads requires a written application for cancellations; the following policy shall apply thereafter:

Ravel Roads requires a written application for cancellations; the following policy shall apply thereafter:

- If cancelled 30 Days prior to departure date from client's side, all previously paid amount(s) will be forfeited.
- If cancelled 31 – 60 Days prior to departure date, 75% of the deposit will be refunded except for the non – refundable deposit.
- If cancelled more than 60 days prior to departure date, all previously paid amount(s) will be refunded, except GST & Service Fee.
- In the event of force majeure, we reserve the right to cancel or reschedule the Kailash Manasarovar Yatra tour without any liability to you. If the tour is cancelled due to force majeure, we will refund your booking fee minus the GST amount and Permit amount.

Force majeure events are unforeseeable and unavoidable circumstances that prevent the performance of contractual obligations. In the context of Kailash Manasarovar Yatra bookings, force majeure events may include natural disasters, political unrest, or other events beyond our control that make it impossible or unsafe to conduct the tour.

Please note that the refund amount will be calculated based on the amount paid by you at the time of booking, and will not include any additional expenses that you may have incurred, such as travel or accommodation expenses.

We strongly recommend that you purchase travel insurance to protect yourself against unforeseen circumstances, including cancellations due to force majeure events. Additionally, please ensure that you keep up-to-date with any travel advisories or warnings related to the Kailash Manasarovar Yatra before booking your tour.

All disputes pertaining to the tour and any claim arising there under shall be subject to the Court of competent jurisdiction at Bangalore only

Kailash Yatra Risks and Liabilities:

The Kailash Yatra is conducted under Chinese Authorities and Foreign Exchange Center Tibetan Autonomous Region (FEC TAR), hence, Ravel Roads will not be liable to any last minute changes, any unforeseen circumstances, and emergency circumstances and evacuations, flight delays, extra nights to be stayed, natural disasters, altitude sickness and rescue. Any extra costs incurred shall be borne by the clients themselves.

Ravel Roads makes every effort to make your journey smooth and pleasant as much as possible. However, we merely act as an intermediary between the concerned airlines, hotels, transport operator and local tourist offices providing the services. Ravel Roads therefore cannot bear responsible for any loss, injury or damage sustained by delay, accident, natural disaster, political action and unrest caused by whatever reason. Program, Prices, services and conditions are based on the terms valid at the time of printing and are therefore subject to change without advance notice in the event of circumstances beyond our control.

1. Cost does not include any insurance against accidents, injuries, sickness, air or surface evacuation, trip cancellation, medical treatment, hospitalization, drugs whatsoever in the event of accident or emergency.
2. On budget tour to Tibet, accommodation is provided in twin bedrooms or dormitory style rooms at Guest Houses or Lodges with basic facility only.
3. All baggage and personal effects are at all times at travelers' risk.
4. Chinese authorities reserve the right to:
 - a. Change the itinerary due to the reason beyond our control
 - b. Alter the length of the itinerary, if necessary
 - c. Increase the cost as a result of change of itinerary

Any increase to be borne by the participants and are liable to be collected directly in Nepal before departure.

In some cases, cost might increase if the group numbers drop below the agreed number at which the trek / tour was originally priced. In the case Ravel Roads most tours/ treks are guaranteed for any number of persons unless otherwise mentioned.

DISCLAIMER: The following terms and conditions govern your participation in the Kailash Yatra pilgrimage organized by Ravel Roads. By signing up for the Kailash Yatra, you agree to be bound by these terms and conditions.

Assumption of Risk: You acknowledge and accept that travel to remote areas, such as the Kailash Yatra, involves inherent risks, including but not limited to risks associated with traveling in high altitudes, exposure to extreme weather conditions, political unrest, accidents, and other unforeseen events. You voluntarily assume all such risks and agree that Ravel Roads, is not responsible for any injuries, illnesses, or deaths that occur during the pilgrimage.

Release and Waiver of Liability: In consideration of the services provided by Ravel Roads, you hereby release, waive, discharge, and covenant not to sue Ravel Roads, its directors, officers, employees, agents, representatives, and assigns, from any and all liability, claims, demands, actions, or causes of action whatsoever, arising out of or related to any loss, damage, or injury, including death, that may be sustained by you or any property belonging to you, while participating in the Kailash Yatra.

Indemnification: You agree to indemnify, defend, and hold harmless Ravel Roads,, its directors, officers, employees, agents, representatives, and assigns, from and against any and all claims, damages, liabilities, costs, and expenses, including reasonable attorneys' fees, arising out of or related to any injury, illness, or death that may occur during the Kailash Yatra, except to the extent caused by the gross negligence or willful misconduct of Ravel Roads,.

Duty of Care: Ravel Roads, will take all reasonable measures to ensure your safety and well-being during the Kailash Yatra. However, Ravel Roads, is not responsible for any injury, illness, or death that may occur as a result of your failure to follow safety guidelines and regulations or any advice given by Ravel Roads, or its representatives.

By signing up for the Kailash Yatra, you acknowledge that you have read and understood these terms and conditions and agree to be bound by them. You also acknowledge that you have had the opportunity to consult with a legal professional of your choosing regarding the terms and conditions of this agreement.

Itinerary may change

We reserve the right to alter, amend, change or modify the tour package and itineraries before or during the tour. We will make reasonable efforts to notify you promptly of such changes as and when they are made.

SPECIAL NOTES :

The Foreign Exchange Rate Similarly the final cost on Nepal side will depend upon the Chinese Visa fees, new permit cost , domestic air fares and other factors. The costs are tentative and may which may subject to revise.

Additional Terms & Conditions

1. With maximum 3-night accommodation and services specified in Kathmandu and for Tibet package with maximum 13 Nights (Overland) / 11 Nights (Helicopter) /14 Nights (Lhasa) accommodation and services specified. Neither of services of these two packages can be adjusted with each other under any circumstances, nor there any compensation or refund for the unused services.
2. If any of the travelers return without completing the tour due to sickness or any reason whatsoever, cost of transportation from tour cancelling point to Kathmandu will be borne by the respective travelers. Besides this, any extra expenses including accommodation, meals, immigration penalty, Nepal visa fee (from Non-Indian only) etc. for his/ her and accompanying staff will have to be borne by the traveler concerned.
3. Accommodation in the local guest house will be provided in dormitory beds in a room with very basic facility, where bathrooms are common and not so clean. If the group decided to stay at a better hotel (where it is available), then the cost of accommodation in the pre-booked guest house is not refundable, it cannot be adjusted with cost of accommodation in the higher standard hotel. Group split in the guest house and hotel will not be permitted as per the rules and regulation of Tibet Government.
4. If tour is cut short in Tibet due to bad weather or any unforeseen reasons whatsoever and group return to Kathmandu prior to the original schedule, then the travelers will have to pay the cost of accommodation. Meals and any service required in Nepal as the unused services and accommodation in Tibet can neither be adjusted with the accommodation and services provided in the Nepal nor it is refundable as per the policy of the Tibet government.
5. If a part of group wishes to return to Kathmandu earlier than the rest, any additional cost involved in the transportation, accommodation, immigration penalty fees, Visa fee etc. applicable to travelers and accompanying staff will be borne by such group.
6. In the event of land slide, road blockage due to natural calamities, political or any reason whatsoever, participants will bear the extra cost of transportation and porters if

required to reach the destination. It may be collected in advance before start of the tour or on the spot depending in the situation.

7. Decision on any issue will normally be taken as per the wish of majority, but final decision will take by the tour leader in the best interest of all concerned.
Pre-booking of accommodation in the guesthouse is not possible in some places. In those cases where accommodation could not be arranged at the guesthouses for any reason whatsoever, alternative accommodation in the tents will be provided.
8. All the arrangements within Tibet are solely at the discretion of Ravel Roads.
9. **Note: Any accommodation and activities in Kathmandu beyond 3 nights are additional. In case of a delay in obtaining the permit from Tibet, or if there is an early return from Kailash, flight cancellations due to weather, or any other unforeseen circumstances, clients will need to cover all related expenses themselves, including any changes to flight dates.**

Important Information for Mt. Kailash Yatris:

10. Your passport must be valid for at least six months from the start date of your yatra.
11. Only new passports are accepted for the visa process. Please refrain from sending an old passport along with the new one, as misplaced old passports will not be our responsibility.
12. Use BlueDart courier to send your passport, as it is the safest and fastest service provider compared to others.
13. If your passport contains a valid Chinese visa, it will be automatically considered canceled during the visa processing for the Kailash Mansarovar Yatra.
14. If you do not have a passport while traveling from India to Kathmandu, Nepal, you must carry your Voter ID card—these are the only valid identification documents for travel to Nepal.

Besides the risk and liabilities mentioned on the tour booking form, I also accept and agree to abide by the additional terms and conditions of Ravel Roads, and I am thus bound hereby.

Kailash Manasarovar Yatra – Important Guidelines

Travel & Itinerary

- No flight ticket booking included in the package.
- Return only by Flexi fare; fixed return tickets are not provided.
- Number of days may increase or decrease depending on conditions; yatrees must adjust accordingly.

- Buffer days: Any day during the yatra can be treated as a buffer day; this cannot be compensated in the itinerary.
- Waiting time at the border is unpredictable and may vary significantly.
- Any delay in Visa, the customer has to reschedule their flight tickets on their own or need to pay extra costing for their accommodation

Food & Accommodation

- Border crossing: All Yatrees must carry eatables until they cross the border.
- Hotel booking at Hot Spring (Manasarovar Lake) is not guaranteed.
- Any accommodation apart from the itinerary has to be taken care by the Clients only. Payments has to be made on spot and no later payment is acceptable

Payments & Costs

- Full payment must be made before undertaking the Yatra.
- Tibet cost escalation will be calculated at the time of travel and must be paid.
- Booking form is accepted only in writing, signed on all pages.
- Maximum group size: 50 participants only.

Temple Visits & Group Discipline

- Temple Darshan is on your own; Yatrees must stand in queue for Darshan.
- Guide/Group leader's decision is final; all participants must adhere.
- Individual delays: If someone is late apart from the group, they must reach the hotel on their own.
- WhatsApp group is strictly for communication; adverse comments will lead to removal.

Emergency & Evacuation

- Helicopter evacuation is possible but requires full upfront payment.
- Emergency evacuation deposit: ₹35,000 per person approxi to be paid at booking; refundable after completion of travel.
- Emergency evacuation cost: 4,000 Yuan approxi.

Visa & Documentation

- ❑ NRI clients must obtain an L visa before arriving in Kathmandu.
- Visa & Permit is not in Ravel Roads hands. Tibet government has to send us the approvals.
- Entering to Manasarovar Lake is Prohibited
- No customer can say its Ravel Roads Fault

- **Access Control:** Entry to Tibet, Lake Manasarovar, and Mount Kailash parikrama is strictly regulated by Chinese authorities. Even with valid permits, access may be restricted without prior notice.
- **Ritual Practices:** Pilgrims may perform rituals at Lake Manasarovar, but **travel agents cannot guarantee parikrama or lake access**. Any denial is a sovereign decision by local authorities.
- **Documentation:** All yatrees must carry valid passports, Chinese visas, Tibet entry permits, and medical clearance. Without these, travel will not be possible.
- **Agent Liability:** Travel agents act only as coordinators. They are **not responsible for decisions made by Chinese border or local officials**.
- **Legal Recourse:** If services promised by the agent (transport, accommodation, documentation assistance) are not delivered, yatrees may seek remedies under Indian consumer law. However, **denial of parikrama or lake access is outside agent control**.
- **Preparedness:** Pilgrims should be mentally and physically prepared for possible delays, cancellations, or route changes.
